NOTIFICATION

In exercise of the powers conferred by proviso to Article-309 of the Constitution of India and in supersession of the existing recruitment rules for the post mentioned herein, the Governor hereby makes the following rules regulating the method of recruitment to the post of **Amin (Gr-C, Non-Gazetted)** of the District Administration under the **Revenue Department**, Government of Tripura, namely:-

- 1. Short title & Commencement:-
 - (a) These rules, may be called "The Recruitment Rules for the post of Amin under District Administration, 2013".
 - (b) They shall come into force on the date of their publication in the Official Gazette.
- 2. The name of the post(s) shall be as specified in Para-1 of the Schedule enclosed at Annexure-I.
- 3. Number, Classification and scale of pay:-

The number of the said post, its classification and the scale of pay attached hereto shall be as specified in para 2 to 4 of the Schedule annexed hereto.

Method of recruitment, age limit, qualification, etc.

The method of recruitment to the said post, age limits, qualifications and other matters relating to the said post shall be as specified in paras 5 to 13 of the said schedule.

- Disqualification:- No person.
 - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules.

- 6. Power to relax:- Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Repeal:- The existing Recruitment Rules for the post of Amin that are in force in the District Administration (Revenue) hereby stand repealed with immediate effect and are replaced by these Recruitment Rules indicated in the Schedule at Annexure-I enclosed.
- 8. Savings:- Nothing in these rules shall affect reservations, relaxation of age limit any other concessions required to be provided for the Scheduled castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.
