NOTIFICATION

In pursuance of the Recruitment Rules issued vide Notification No. F.10(30)-REV/14, dated 22.07.2021 of this department for the post of Accounts Officer (A/O), Gr-B (Gazetted) and in partial modification of all earlier order the constitution of Departmental Promotion Committee (DPC) for Group – D (Non-gazetted) staff to Group – B (Gazetted) officer under District Administration (Revenue) Department are as follows:-

1. The District Magistrate & Collector, West Tripura, Agartala – Chairman;
2. The District Magistrate & Collector, South Tripura, Belonia – Member;
3. The District Magistrate & Collector, Gomati District, Udaipur – Member;
4. The District Magistrate & Collector, Sepahijala District, Bishramganj – Member;
5. The District Magistrate & Collector, Khowai District, Khowai – Member;
6. The District Magistrate & Collector, Dhalai District, Ambassa – Member;
7. The District Magistrate & Collector, Unakoti District, Kailashahar – Member;
8. The District Magistrate & Collector, North Tripura, Dharmanagar – Member.

The aforesaid Chairman, DPC shall convene the DPC meeting from time to time for promotion to the post of A/O, Gr – B (Gazetted) from the post of Office Superintendent (O/S), Gr – B (Non-Gazetted) and shall send the recommended list to the Secretary, Tripura Public Service Commission (TPSC) for their concurrence. While sending the recommended list of the DPC to the TPSC for this promotion should reflect the ACR grading of the candidates accompanied with Integrity Certificate and Vigilance Clearance.

Subsequently, on obtaining approval of the TPSC, the Chairman, DPC shall furnish the list of recommended Accounts Officer (Gr-B, Gazetted) to the Revenue Department for approval. On receipt of approval from the Revenue Department, the aforesaid Chairman, DPC shall issue Notification for promotion to the post of Accounts Officer.

In case of Inter-District transfer DPC for the A/O (Gr-B, Gazetted) the transfer Notification also will be issued by the Chairman, DPC i.e. DM & Collector, West Tripura.
