**NOTIFICATION**

In exercise of the powers conferred by proviso to Article-309 of the constitution and in supersession of the existing recruitment rules for the post mentioned herein, the Governor hereby makes the following rules regulating the method of recruitment to the post of Revenue Inspector in the District Administration (Revenue) Department namely:

**1. Short title and commencement –**

- (1) These rules may be called the Revenue Inspector of District Administration (Revenue) Department Recruitment Rules, 2022.
- (2) They shall come into force on the date of their publication in the official Gazette.

**2.** The name of the posts shall be as specified in Column-1 of the Schedule enclosed.

**3. Number, Classification and scale of pay:-**

The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in rows 2 to 4 of the Schedule enclosed at Annexure – I.

**4. Method of recruitment, age limit, qualifications, etc.:-**

The method of recruitment to the said posts, age limits, qualifications and other matters relating to the said posts shall be as specified in rows 5 to 13 of the said Schedule.

**5. Disqualification: - No person –**

- (a) who has entered into or contracted a marriage with a person having spouse living;  
or
- (b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.


**6. Power to relax:-** Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in the writing, and with concurrence of the GA(P&T) Department, relax any of the provisions of these rules with respect to any class or category of persons.

**7. Repeal:-** The Recruitment Rules for the aforementioned posts existing in this Department as issued vide Notification No.F.70(143)-REV/76 (L), dated 12.10.1988 are hereby stand repealed with immediate effect and are replaced by these Recruitment Rules according to the Schedule at Annexure- I enclosed herewith.

**8. Savings:-** Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

**9.** This Notification is issued as per the new Recruitment Policy vide Notification No.F.20(1)-GA(P&T)/18, dated 29.10.2020 issued by the Government in the GA(P&T) Department.



SCHEDULE

Recruitment Rules for the post of Revenue Inspector under the District Administration, Revenue Department, Government of Tripura

- 1 Name of the post(s) : **Revenue Inspector**
- 2 Number of post(s) : 59 (fifty nine) plus additional post(s) as and when created.
- 3 Classification : Group- 'C', Non-Gazetted.
- 4 Scale of pay : Rs.34700/- initial pay at level 10, of the pay matrix-2018 subject to revision by the Government from time to time.
- 5 Whether selection post or Non selection post : Selection
- 6 Age limit for direct recruitment : 18 to 40 year of age. Upper age limit is relaxable by 5 (five) years in case of SC/ST/PH candidates and Government servant.
- 7 Educational and other qualifications required for direct recruitment : Graduation from a recognised University.  
Desirable:-  
i) Knowledge of Bengali language or any Tribal language of Tripura.  
ii) Knowledge of Revenue Law in Tripura. Experience in Revenue Work.
- 8 Whether age & educational qualifications prescribed for the direct recruitment will apply in the case of promotion. : "Age" - No  
"Qualification" - No
- 9 Method of recruitment whether by direct recruitment or by promotion or transfer on deputation and percentage of the vacancies to be filled by various method : i) 60% by promotion and 40% direct recruitment through combined competitive examination for recruitment through combined competitive examination for recruitment to the miscellaneous posts.  
ii) The syllabus & procedure or recruitment will be as mentioned in 'The Tripura Combined Competitive Examination.'

- 10 Period of probation, if any. : 2 (two) years.
- 11 In case of recruitment by promotion / transfer on deputation, grades from which promotion / transfer on deputation is to be made : From Tehsilder having minimum qualification of H.S. (+2) passed with at least 5 years experience in service as Tehsilder.
- 12 If a DPC exists, what is its composition : DPC consists of 8 (eight) D. M. & Collectors.
- 13 Circumstances in which TPSC is to be consulted in making recruitment. : As required under the TPSC (exemption from consultation) Regulation-1973.
- 14 Repeal : The existing Recruitment Rules for the post of Revenue Inspector vide Notification No.F.70(143)-REV/76(L) dated 12-10-1988 hereby stands repealed.
