**NOTIFICATION**


In public interest and exercise of the powers conferred by sub-section (1) of Section 3 of the Tripura Land Revenue and Land Reforms Act, 1960 and as per approval of the Council of Ministers vide Memo. No. F.1(24)-GA(CAB)/2010 dated 1<sup>st</sup> January, 2021, the Governor of Tripura is pleased to notify the delimitation of administrative jurisdiction in between Mohanpur and Sadar Sub-Division and creation of a new Revenue Circle namely "Barjala Revenue Circle" under Sadar Sub-Division in West Tripura District.

The jurisdiction of newly created Revenue Circle namely "Barjala Revenue Circle" shall be under Sadar Sub-Division in West Tripura District including the Revenue villages (Moujas) as indicated in the below schedule:
